Bianca reported that the District Conservationist vacancy for the Frenchtown office is open and applications can be submitted through [www.usajobs.gov](http://www.usajobs.gov) until midnight of Monday, May 10<sup>th</sup>. Until the position is filled, Bianca Diaz is assuming the Acting District Conservationist role.

NRCS received fifty-six applications from applicants in Hunterdon County. Thirty-five applications have been pre-approved, twenty-four of which are Hunterdon County participants.

Application sign-up cut off date for new applicants interested in participating under the Conservation Stewardship Program (CSP) is Friday, May 7<sup>th</sup>.
