Christmas Tour and Dinner – December 14 – Update – Due to the pandemic, it was recommended to not have the annual tour and dinner, but postpone it until next year or after virus is no longer a threat. Chairman Manners questioned the amount of ICM money for the past year since the program was terminated. This number was based on a deferred portion of the fees.
