Implementation of a Comprehensive Nutrient Management Plan

- Dairy – Close existing manure lagoon and replace with a new above ground tank -Heifer facility – Remove feed bunker and concrete. Build an HUAP, Manure Storage Facility and Roof runoff structures. Pasture seeding fence off stream access

Manager DePalma expressed concern about the Readington Twp. CTA Plan and asked if this high tunnel referred to the existing high tunnels on the farm. He has been working with the engineer for that property on a Stormwater Management Plan for the existing high tunnels on farm. Craig said he would double check with the planner, but the plan should not cover any of these hoops and would not exempt Stormwater Management.
